#### **PRIVACY POLICY**

#### 1. Information We Collect

We collect the following types of information based on your interaction with the platform:

## 1.1 From Schools:

- a) School name, address, contact details
- **b)** Administrative contact information (email, phone, designation)
- c) Academic data, fee structure, amenities, photos, and awards
- d) User account credentials for ERP or dashboard login
- e) Bank details for payment processing (where applicable)

## **1.2 From Students & Parents:**

- a) Student name, age, class, academic history (if submitted through enquiry or admission forms)
- **b)** Parent/guardian name and contact details
- c) Location or area preferences for school searches
- d) Payment details when paying school fees through the platform

#### **1.3 Automatically Collected Data:**

- a) IP address, browser type, operating system
- **b)** Device information and access times
- c) Browsing behavior on our website (e.g., schools viewed, time spent)

#### 2. How We Use Your Information?

We use the information collected for the following purposes:

- a) To list and display school information to users searching on the platform
- b) To process and manage student enquiries and admission requests
- c) To enable ERP features for registered schools (attendance, fees, academics, etc.)
- d) To process payments securely via integrated payment gateways

- e) To send important service updates, alerts, or promotional communication (with optout option)
- f) To comply with legal and regulatory requirements

# 3. Sharing of Information

We do not sell or rent your personal data to third parties. However, we may share your information in the following cases:

- a) With authorized service providers or partners (e.g., payment gateway providers, SMS/email service partners) strictly for operational purposes
- b) With law enforcement or government bodies when legally required
- c) With other users (e.g., schools receiving enquiry data submitted by parents)

# 4. Data Security

We implement strong physical, technical, and administrative safeguards to protect your data, including:

- a) SSL encryption for data transmission
- **b)** Secure login with role-based access for ERP users
- c) Limited access to sensitive data to authorized personnel only
- d) Regular security audits and data backups

# 5. Cookies and Tracking Technologies

We use cookies and similar technologies to:

- a) Remember user preferences
- **b)** Improve user experience
- c) Analyze site performance and usage

Users can disable cookies in their browser settings, but this may affect some features.

# 6. Data Retention

We retain your personal data:

- a) For as long as necessary to provide services or as required by law
